INSTRUCTIONS

The registration form on the facing page should be used to register all drivers, judges, spouses, and guests. Please complete the appropriate section(s). Use one form per person (NOTE: Driver and their spouse/guest and children can be registered on one form). Please print all information.

HOW TO REGISTER

Step 1- Complete the registration form provided in this booklet. This includes both the front and back side of the facing page. This includes the "Verification of Driver Eligibility" and the "Driver Information" on the last page.

Step 2 - The "Verification of Driver Eligibility" form must be signed by the CEO, Division President, or VP of Distribution, Operations, or Transportation.

Step 3 - Provide a copy of the driver's motor vehicle report from the Department of Motor Vehicles.

Step 4 - Provide a photocopy of the driver's CDL.

REGISTRATION FEES

Payment must be included with registration.

Drivers: \$345 per driver for IFDA Member Companies and \$445 per driver for Non-Member Companies (does not include spouse/guest).

Banquet Only: \$150 each.

Judges: \$100 each.

Spouse/Guest: \$275 each.

Children: We welcome children at this event! Parents must register all children under 18 who are attending. The cost is \$50 per child (ages 5 - 17). Children under 5 are complimentary. The charge helps to cover a portion of the cost for lunch on the field course and for the Awards Banquet.

General Registration: \$345 for IFDA Member Companies and \$445 for Non-Member Companies (includes management and spectators who wish to attend Truck Driving Championship related events and the Sunday Awards Banquet).

Please Note: Fees for multiple registrations may be totaled and paid with one method of payment (include payment with registrations).

Section I: ADVANCE REGISTRATION (for drivers not yet identified)

- Deadline: August 13, 2010
- Use for reserving a spot in driver class before individual contestants have been determined.
- Include the name of the transportation/operations executive who will be the contact person for your company and who will receive all correspondence.
- Your advance registration will serve to hold a spot for not more than one driver per class from each operating location/division.
- Submit total payment as applicable.

Section II: DRIVER REGISTRATION

- Deadline: August 13, 2010
- If you made an Advance Registration, use this section for providing driver information.
- Provide the last four digits of the driver's Commercial Drivers License (CDL). This will be used for posting scores anonymously onsite.
- Indicate driver shirt size in the box provided. Please make sure the size is accurate as no exchanges can be made.
- List the name of the driver's spouse/guest if attending.
- Submit total payment as applicable.

Section III: JUDGE REGISTRATION

- Indicate shirt size in the box provided.

The following driver is registered to compete in the Food Industry Truck Driving Championship, September 10-12, 2010 in Lake Buena Vista, Florida.

DRIVER NAME

This is to verify that the driver named above meets the following eligibility requirements:

1. At least one year of continuous full-time employment as a driver with a food distribution company (i.e., foodservice, foodservice manufacturer with private fleet, retail/wholesale grocery), and is currently a full-time driver (not a supervisor).
2. The driver is the winner of a company-sponsored competition (at a distribution center or higher level), or is the highest placing company representative at a state, local, regional, or provincial truck driving competition. If the highest placing driver is not a first place winner, a minimum number of two drivers from the location/company competed in that class.
3. A Driver Record that meets the following:
A competing driver must have a "CLEAN" driving record for one year prior to September 10, 2010. A "CLEAN" driving record means no chargeable accidents, and no alcohol or drug-related charges.
4. The driver holds a valid license for the type of truck to be driven during the competition.
