#### Incident Summary:

The Cybersecurity and Infrastructure Security Agency (CISA) continues to monitor the evolving Coronavirus Disease, also known as COVID-19, situation closely. CISA is taking part in interagency and industry coordination calls and working with critical infrastructure partners to prepare for possible disruptions to critical infrastructure that may stem from widespread illness.

FEMA reports approximately 10,922,324 cases and 523,011 deaths worldwide. In the U.S. there are approximately 2,841,906 cases and 129,576 deaths.

- Texas, Arizona, and Florida have become hotspots, recording six straight days of confirmed new cases above 5,000

#### CRITICAL INFRASTRUCTURE IMPACTS:

##### HEALTHCARE AND PUBLIC HEALTH

The United States has been put on England's travel "red list," meaning that people visiting from United States will be forced to quarantine for 14 days upon arrival starting on 10 JUL.

The FDA has authorized 162 tests under emergency use authorization (EUAs); these include 136 molecular tests, 25 antibody tests, and one antigen test.

The FDA is warning consumers and health care professionals about hand sanitizer products containing methanol, or

wood alcohol - a substance often used to create fuel and antifreeze that is not an acceptable active ingredient for hand sanitizer products and can be toxic when absorbed through the skin as well as life-threatening when ingested.

A pharmaceutical company announced positive results from their Phase 1 and 2 trials of a COVID-19 vaccine. Indicating the vaccine was safe and produced COVID-19 antibodies; the vaccine is expected to move to Phase 3 trials in early July, with 1.2 billion doses potentially manufactured by the end of 2021.

### TRANSPORTATION SYSTEMS

The Virginia Department of Transportation (VDOT), in partnership with the Department of Rail and Public Transportation, has launched the Virginia Commuter Survey. This statewide effort will gauge COVID-19 impacts to commuting around Virginia.

### ACTIVATIONS AND DECLARATIONS

The Mayor of Cleveland, OH signed an order requiring the use of masks for all individuals out in public or in public spaces including businesses and restaurants.

The Governor of Texas has issued a proclamation giving mayors and county judges the ability to impose restrictions on some outdoor gatherings of over 10 people, and making it mandatory that, with certain exceptions, people cannot be in groups larger than 10 and must maintain six feet of social distancing from others.

Indiana is pausing parts of its reopening plan because of increases in COVID-19 cases and hospitalization rates.

Chicago, IL Department of Public Health Commissioner issued an Emergency Travel Order directing travelers from 15 states seeing a surge in COVID-19 Cases to quarantine for 14-days upon arrival in Chicago.

Puerto Rico is planning to reopen on 15 JUL to inbound travelers with proof of a negative molecular COVID-19 test 72 hours prior to arrival. Those who refuse to test, test positive, or do not have the test results available will be required to complete a two-week quarantine.

Zero states and territories have complete stay-at-home orders in place. Four states have stay-at-home orders; however, only limited movement restrictions. Forty states and territories have lifted their stay-at-home orders, though other movement restrictions may still apply. Two states lifted state-wide orders, but maintain regional stay at home orders. Three states have not issued state-wide stay at home orders and have lifted all regional orders. Seven states and territories never enacted stay at home orders.

Zero states/territories have all restrictions on nonessential businesses in-place; zero states/territories have lifted limited restrictions on nonessential businesses; eight states have lifted some restrictions; one states/territories have regional lifting of some restrictions; thirty-seven states have lifted most restrictions; five state has regional lifting of most restrictions; seven states have lifted all restrictions; two states have not closed nonessential businesses; and two states are special cases.
